**We also organize local meetups for people who are in a faith transition. We do events where the activity and food are paid for by the Organization. This allows us to meet in person people in spiritual pain and to offer support and community. This reach approximately 500 people in 2021.**

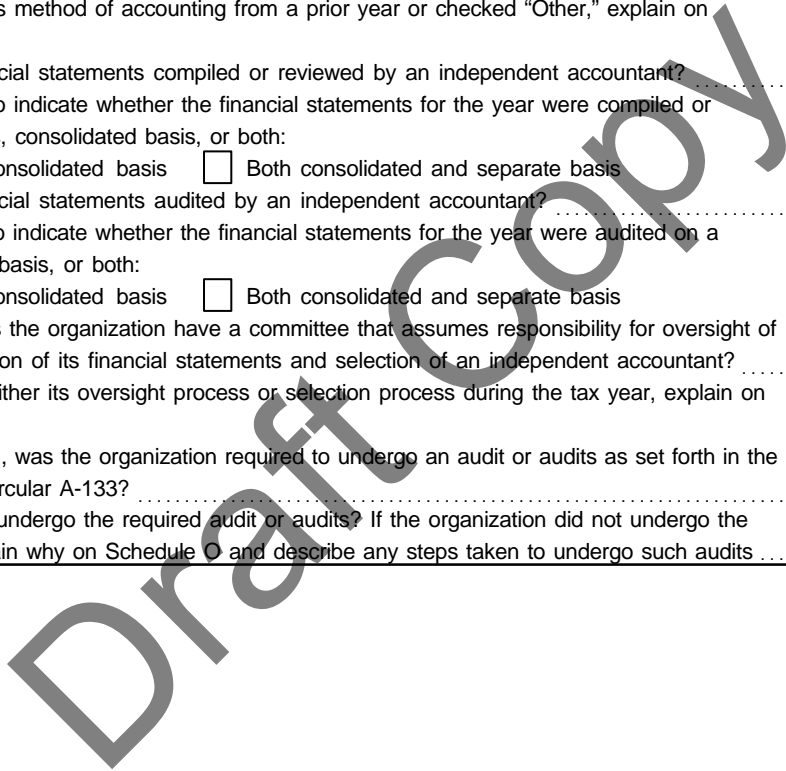

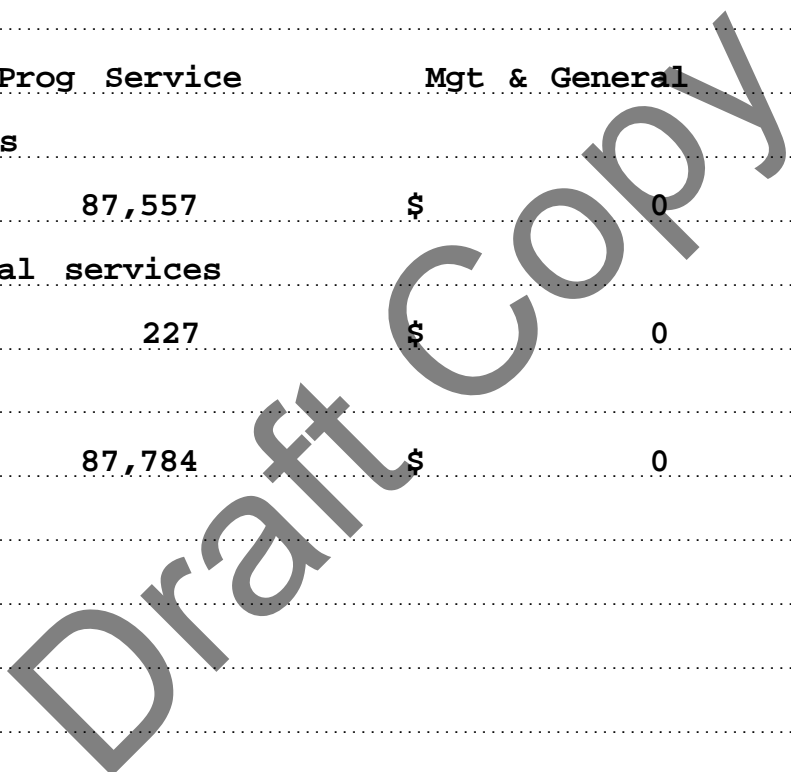
