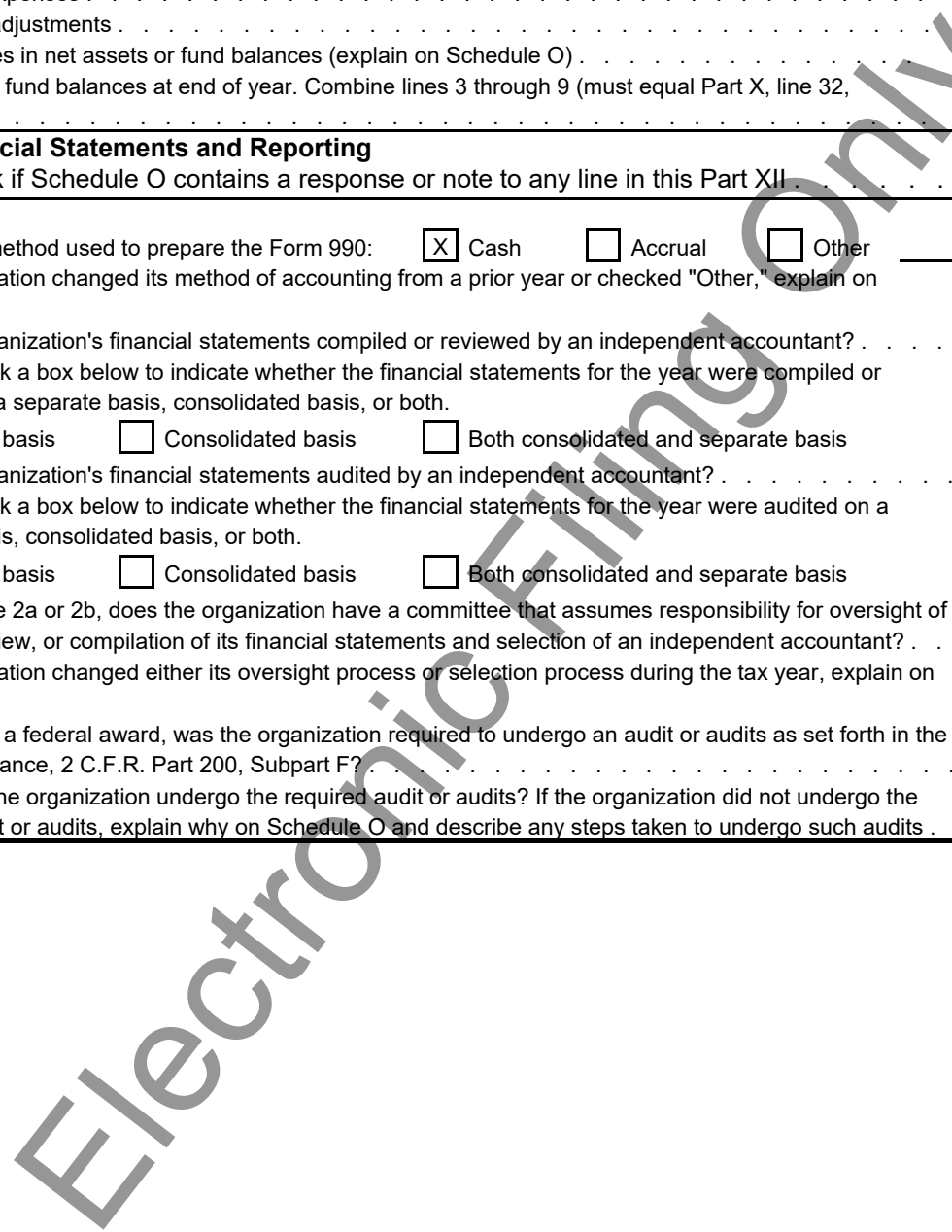

RELATED TO SAID CONFLICT OF INTEREST OR B) TERMINATING EMPLOYMENT WITH MORMON DISCUSSION INC.

AFFECTED PARTIES BOTH WITHIN AND OUTSIDE OF MORMON DISCUSSION INC., INCLUDING SHAREHOLDERS,

DIRECTORS, EMPLOYEES AND INDEPENDENT CONTRACTORS WILL BE NOTIFIED. IF THE CONFLICT OF INTEREST

IN QUESTION INVOLVES A MEMBER OF THE BOADR, THAT INDIVIDUAL WILL BE EXCUSED FROM

DELIBERATIONS.
